FOR: Spring 2023 Programs

FINANCIAL OBJECTIVE AND JUSTIFICATION STATEMENT

Financial objectives vary among cost centers or program areas. In general, fees are calculated to cover the direct cost of the program with a pre-determined minimum number of participants and then increased by 20% to cover administrative costs. Program fees are recalculated each time they are offered to account for any changes in costs. We also consider price breaks, competition, and what the market will bear when establishing program fees.

PROJECTED RESULTS / OUTCOME:

Spring programs are held March-May. During the spring of 2022, we offered 141 fee-based programs and collected \$49,793.96 in revenue. This spring we will offer 151 fee-based programs and revenues may be impacted by pandemic restrictions.

We are asking for the Board of Park Commissioners' approval of the Winter Fun Times as presented. To be responsive to unforeseen circumstances such as health emergencies, severe weather, etc.) we ask for the Board of Park Commissioners' approval for the authority to modify, adjust and add programs (and their associated fees if applicable) with written approval from the Deputy Director or Director.

FINANCIAL OBJECTIVE AND JUSTIFICATION STATEMENT:

Headwaters Park, located just north of the central city business district, is home to many festivals, concerts, charitable and other special events. The large open-air pavilion is available for public rental and makes a wonderful setting for weddings, receptions, company picnics, and family reunions. During the cold weather months, the pavilion houses the popular Headwaters Ice Skating Rink.

In the late 1990s, the developing Headwaters Park project became one of the largest public-private partnerships existing in Northern Indiana. Together, both the public and private sectors raised nearly \$17 million to complete the downtown revitalization. Because of its broad appeal, support came from all areas of the community. The State of Indiana contributed \$2 million, mostly through Build Indiana funds for land acquisition. Fort Wayne and Allen County governments contributed \$5.2 million for land acquisition, environmental remediation, and business relocation costs.

On April 1, 2023, the Fort Wayne Parks Department will take over the operation of Headwaters park from the Headwater Park Alliance. To make sure the transition is as easy for the Fort Wayne Parks Department and Headwater Park renters we are suggesting that rental pricing for the park remain mostly the same as in 2022 as previously established with the Headwaters Park Alliance. The park will be operated in a similar structure as with events in 2022. Rental spaces will be focused on 4 primary areas Grassy Area (East Side), Grassy Area (West Side), Lincoln Financial (East), and Pavilion Madge Rothschild Pavilion (West).

FEE RECOMMENDATION

- Fees will remain mostly unchanged for 2023
- Propose the creation of a 428-capital fund to help with future repairs and maintenance of the park. 15% of all rental and admission fees would be put into this fund.

PROJECTED RESULTS OUTCOME:

We anticipate these fees will bring an additional income from the rental cost of the park and the Ice-Skating Rink operation.

FINANCIAL OBJECTIVE AND JUSTIFICATION STATEMENT:

Sweet Breeze canal boat is Fort Wayne's only authentic canal boat replica. It is a flat-bottomed, aluminum-hulled boat that is 54' long, and has a draft of 2.75' and an air draft of 8.5'. The vessel is owned by Friends of the Rivers and operated by the Fort Wayne Parks and Recreation Department. 2021 was FWPRD's first year operating the boat. Tour options include 45-minute tours, 60-minute tours, 90-minute tours, private rentals, and field trips, with a scheduled season from late-May or early June to mid-October.

The financial goal for The Sweet Breeze is to be self-sustaining covering operating costs through tours and private rentals. FWPRD's largest hurdle and top priority going into the 2022 season was to recruit, hire and retain more staff. With limited staff in 2021 and burnout at the end of the season, FWPRD knew this problem needed to be solved to be successful in the long run. FWPRD's goal was to hire at least 6 new staff members to reduce pressure and burnout for the returning staff. There was 8 additional staff hired in 2022, despite an extremely challenging and unique job market. Training staff for this operation is extensive and it is important to have returning staff each year, specially trained captains. To cover staff expenses and staff growth we would like to propose an increase in regular public tour ticket pricing, community tour pricing, Friends of the Rivers (FOR) education tour rate, FOR program tour rate, and the FWPRD in-house tour rate.

Projected Results / Outcomes

• With the proposed updates, we anticipate additional revenue of \$12,743

 - The rate and number of tours will be negotiated and agreed upon by both parties in writing before the beginning of each season. (Deputy Director or Director for FWPRD and designee)
 - o FOR will pay FWPRD the difference between the general public tour ticket price while retaining the special event price.
 - o For example, 45-minute general public tours are \$17 (The year 2022 pricing)
 - World River Day special event price is \$5/rider for a 45-minute tour
 - FOR agrees to pay the \$12 per ticket difference to FWPRD
 - FWPRD will also keep the special event price of \$5/ rider

Memorandum of Agreement

This memorandum of Agreement ("MOA") is entered into as of this 9th day of February 2023 (the "Effective Date") by and between the CITY OF FORT WAYNE BOARD OF PARK COMMISSIONERS, by and through the Fort Wayne Department of Parks and Recreation ("Parks") and Friends of the Rivers, an Indiana non-profit corporation ("FOR"). Parks and FOR are sometimes referred to herein individually as a "Party" and collectively as the "Parties".

RECITALS:

Parks and FOR entered into a Bareboat Charter Agreement ("Agreement") on the 26th day of May 2021 (the "Effective Date". Section 21 of the Agreement allows for the parties to mutually agree to Amend the Agreement.

The items below are the recommended amendments to the agreement.

- 1. Replace EXHIBIT A with an up-to-date inventory of vessel equipment. (See attached)
- 2. Change section 2 from January 31st to February 15th for the submission of each calendar year following the conclusion of an Operation Season during the Charter Period or any Renewal Charter Period (as hereinafter defined), Charterer shall provide the Owner with a financial summary report of revenues, expenditures, attendance, tours, the performance of maintenance, and repairs, and other information for the preceding Operation Season (the "Operating Season Financial Summary Report")
