Scope of Work:

This project includes pavement repairs, sealing, and striping to twenty-six parks with varying levels of service based on the condition of the infrastructure. Selection of the locations is guided by annual park assessments and rotation of work completed each year.

Three quotes were received through a public, open bid process on behalf of the Board of Park Commissioners on January 31, 2023, and Line Design, Inc. was the lowest bidder.
