**RULES AND REGULATIONS**

Thank you for choosing the Johnny Appleseed Campground! **The site listed above is subject to change based on site availability when you arrive.** Failure to comply with Campground Rules, Fort Wayne Parks and Recreation Rules, City of Fort Wayne Ordinances, and local and federal laws may result in termination of the reservation without refund.

- Campground deposits/payments are NON-REFUNDABLE.
- Tent camping is limited to three nights per reservation. There is a seven day grace period in which a tent camper must wait to be able to reserve a tent site again. No extensions permitted.
- Check-in time is 2:30pm and check-out time is 2pm.
- If you need an earlier check-in time please call the campground at 260-427-6720 before your arrival for availability.
- One vehicle is permitted site. No unlicensed vehicles in the campground. **DO NOT PARK ON GRASS**, unless you are authorized to do so. RVs, cars, trailers, boats, motorcycles, vehicles, etc must be parked on gravel. Guests must park outside campground in public parking.
- Office hours are Monday – Friday 9am-5pm and Saturday & Sunday 10am-5pm (EST) May to the end of October.
- 5 MPH speed limit in the campground.
- **QUIET TIME: 10PM to 8AM.**
- Alcohol, drugs, fireworks, abusive language, threaten behavior, loud vehicles, threats/physical violence toward another camper is not permitted in the campground.
- Johnny Appleseed Campground is a City of Fort Wayne and Fort Wayne Parks and Recreation property, items such as mats/rugs, trailers, personal items, satellites, inflatables, kennels, décor, clothes lines, etc that are deemed unsightly, obscene, a safety/health concern, or damaging to the property are not permitted. The Camp Hosts and Manager of Outdoor Recreation reserve the right to enforce this rule and ask owners to remove and/or dispose of such items.
- Items abandoned at the campground will be held for seven days. If left unclaimed the items will be disposed.
- Satellite dishes may have to be moved for mowing or other maintenance. If the owner is not available to do this, the Camp Hosts have permission to move the dish antenna or other items.
- **ABSOLUTELY--NO DUMPING OF BLACK/GRAY WATER ON THE GROUND.** Use the dump station provided free to registered campers. Pump truck service is available for a fee of \$10. Pump truck hours are Noon to 3pm Monday through Sunday. For same day pumps hosts need to be notified in the morning before noon. All side outs must be pulled out before pump service. If caught dumping on ground, you will be asked to leave and no refund given.
- Pets must be kept on a leash at all times. **YOU MUST CLEAN UP AFTER YOUR PET** and not leave them unattended. Please keep your pet quiet!
- Cars, RVs, pets, services or other property cannot be sold in Fort Wayne City Parks.
- Campfires are restricted to the fire rings only. Campfires are not permitted on sites 1, 10, 12, 15, 40, 41, 42, 43. **(DO NOT PUT TRASH IN FIRE RINGS OR RESTROOMS.) DO NOT MOVE FIRE RING.**
- Place picnic table back as found. **DO NOT** leave anything, take what you bring.
- The Campground will close for the Johnny Appleseed Festival 9/15/2024 at 2:00 pm and reopening on 9/26/2024 at 2:30 pm.
- Children under 18 must be accompanied by an adult at all times & locations in the campground. This includes the shower facility & laundry room. Parents are responsible for their children.
- TV Stations: 15-CBS, 21-ABC, 21-2-NBC, 39-PBS, 55-FOX \* **WE DO NOT HAVE CABLE\*** Fort Wayne is in Allen County.
- Shower Combinations: MEN - \_\_\_\_; WOMEN - \_\_\_\_; LAUNDRY - \_\_\_\_ **DO NOT give out these combinations for your safety!**
- During severe weather take shelter in the shower house.
- Wifi information for Johnny Appleseed Campground guests: internet4johnny.

**Payment Guidelines & Authorization**

- We require a valid credit card or debit card on file for all reservations.
- A \$30 non-refundable deposit is processed in order to hold your reservation (first night).

**Daily / Weekly Stays**

- Your credit card will be charged a deposit of the first night (\$30).
- Remaining balance is due upon arrival.

**One Month – 28 day reservation**

- Your credit card will be charged a deposit of the first night (\$30).
- Remaining balance is due upon arrival.

**Extended Stay**

- Your credit card will be charged a deposit of the first night (\$30).
- Upon arrival the first monthly payment (20 days) is due.
- Once the next 20 day begins the next payment is due. (payment is due day 1 of the next 20 days)
- If funds are not received the credit card on file will be charged to collect full payment due.
- If funds are not available on the credit card on file, guest services will be terminated and a Notice to Vacate immediately will be delivered.
- The credit card must be a MasterCard, Visa, Discover Card, or American Express, and not expired.
- Credit card information will be kept in a secure location and shredded at the end of the campground season.
- Rates displayed in this receipt do not include any applicable service fees or charges for any other incidentals. Service fees and other incidentals are due upon request.

**Release and Indemnity**

Failure to comply with the Campground Rules, Fort Wayne Parks and Recreation rules, City of Fort Wayne Ordinances, local and federal laws may result in termination of your reservation without a refund. Upon termination and time to vacate costs of removing items, towing of RVs or labor to move may also be applied. Campers using Johnny Appleseed Campground do so at their own risk and they assume full responsibility for any injury occurring them or members of their party. Camper further agrees to waive all claims against Board of Park Commissioners (BPC), Fort Wayne Parks and Recreation (FWPR), Johnny Appleseed Campground (JAC) and the City of Fort Wayne (CFW) on account of any loss, damage, stolen or injury from whatever cause which may occur to it or its property in the use and occupancy of the premises.

VIOLATION of the RULES by Camper(s) or his/her party, including failure to pay when due, at Fort Wayne Parks and Recreation discretion could terminate campers right to use the Johnny Appleseed Campground, eviction and no refund.

Camper(s) hereby forever waives and releases BPC, FWPR and the CFW and their respective officers, directors, members, employees, volunteers, representatives, departments and divisions from any and all claims, demands, charges, liabilities, obligations, judgments, costs and expenses, both known and unknown and whether now existing or hereafter arising, which are related to, connected with or in any manner arise out of exercise of Campers' rights and performance of Campers' obligations under this release, but excluding therefrom any claims ensuing from the negligent or intentional acts or omissions of BPC, FWPR or CFW in connection with the management use, operation and control of JAC.

By using a credit card for a deposit, guarantee or payment, you agree to the following: I acknowledge that my credit card used for deposit, guarantee or payment, I authorize Johnny Appleseed Campground to charge any expenses incurred during my stay to that credit card or apply funds you have on deposit with Johnny Appleseed Campground against what I owe.

By signing this release, I acknowledge that I have read, understand and agree to the rules, payment guidelines, and payment authorization for the Fort Wayne Parks and Recreation's Johnny Appleseed Campground.
